With due respect, I am hereby describing the incident took place on 29th of May 2022 in newtown campus. As someone complained against me to UGC (Complaint No. WB_0040 dated: 29th May 2022)

As usual I came to the university on the said date for my research work and a meeting of AUTMCP was also scheduled on that day to which I am associated with.I came out of my Lab for a tea break and found that our AUTMCP flags are lying here and there and in place of our displaced flag SFI flag was placed. After reaching 2nd gate I found that around 5-6 person (not our students) trying to enter our campus and of our security named Tarun mondal instructing 2nd gate keeper to let the outsider enter. I informed my fellow AUTMCP members that our flag have been torned and replaced with SFI flag. When I was coming back from 2nd gate I saw 2 students armed with iron bar and with SFI flags. I asked them why they have torned our flag.; instead of a polite answer they started abusing me using slung languages. It makes me furious. At that moment several other AUTMCP and SFI with outsider came at that place. There have been some hot talk and pushing and pulling for a while. Then one of the SFI members fell down on the ground. Then I realize that it have to be stopped. I pleaded to everyone to stop and asked outsider to go out of campus.

I strongly feel that initially become infuriated in their provocation was not suitable for me. They are my junior fellow like my younger brother. I apologize for that.

Conclusions of the investigations

The members of the anti-ragging committee, after hearing the allegations of the complainant and after hearing the statements of the accused and investigating the CCTV footage, came to the conclusion that

- 1. The first complaint of the complainant was that he was going to attend a seminar but there was no seminar at the university that day and he was join activity that is student organization activity those are not permitted by the authority of the university. The student provided this wrong information to UGC which is written in Annexure-A.
- 2. The complainant admitted that he had made a mistake in not informing the university after the incident and under the guidance of friends, he complained to UGC without informing the university.
- 3. As per his 2nd Complained- "How can PhD Scholars bring a physical attack on Junior brother"- CCTV footage shows students from the two organizations arguing with each other and then students from the two organizations beating each other. There are no iron rings or big bamboo sticks that the complainants have complained about but they are fighting with hands and flag streaks. So, this incident is not a ragging because it involves clashed between two groups of students' organizations during hosting and toned down the respective organization flags and the complainant (Mr. Sakil Aktar, Roll No. ECO193008) also agreed that this incident is not ragging; it is clashed between two groups of student organization.
- 4. Committee Counseled both Victim and accused separately. Both sides acknowledged that they should not have been involved and they have admitted to the committee that such incidents will not happen again in the future and further no incident was happened till now after complain. He is secured & safe.

Based on the statement of the complainant the two accused students (Mr. Mansur Habibullah, Roll No. JMC212018 and Mr. Mirajul Islam, Roll No. BNG192601) are present and expressed their opinion in this regard. They were asked in detail and were requested to submit their statements in written form which are attached in Annexure-B, Annexure-C. The Anti-Ragging Squad submitted a comprehensive investigating report with all the facts and documents to the Anti-Ragging Committee. On that matter a meeting of Anti-Ragging Committee was held on 08.06.2022 at Board Room, Aliah University, Newtown Campus.

Report of the Anti-Ragging Squad (Ref No. ARCC/WB-6823)

- A complaint was received from UGC through Registrar, A.U. Ref. No. ARCC/WB-6823, Dated: 09.02.2022.
- 2. The initial letter didn't disclose the identity of the complainant. Therefore, communication was made with UGC and the identity of the complainant was established.
- 3. The Anti-Ragging Squad convened an investigation meeting comprising all its members and complainant (Mr. Mijanur Rahim, Roll No. ECE181603) was called on 22.02.2022 at Seminar Hall, 2nd floor, Newtown campus, Aliah Uninersity where the details of his complaint were recorded in words. The statement of complainant is attached in Annexure- A.
- 4. Based on the statement of the complainant two students (Mr. Mansur Habibullah, Roll No. JMC212018 and Mr. Mirajul Islam, Roll No. BNG192601) were also called in a hearing on the second meeting of Anti-Ragging Squad on 04.03.2022 at Seminar Hall, 2nd floor, Newtown campus, Aliah Uninersity. - 1. Mr. Mizanur Rahim, (Roll No. ECE181603) one of the most senior students in our university from 2010 and he is a research scholar of our university. The accused students Mr. Mansur Habibullah and Mirajul Islam are junior than the complainant. The complainant and accused students both were engaged in telephonic threatening, related to their personal issues which have been reported in Annexure A and B. and the conversationhad taken place in social media and it was not happened within the university premises so, it cannot be referred as a ragging but it was a wrangle between two students.
- 2. In October 2021, the university hostel was totally closed due to the COVID-19pandemic situation. So, there is no possibility to happen such incidents in our university and hostel premises. Mr. Mizanur Rahim did not inform to the university authority at first. Instead of informing the university authority at the first stage, he immediately lodged a complaint to the UGC Anti-Ragging Cell whichwasunfortunate to us and he has also admittedthat he had made a mistake for the same.
- 3. University authority provided adequate safety and security with adequate CCTV within the hostel premises as the complainant asked for the safety and security from the university authority.
- 4. Anti -Ragging Squad and Anti-Ragging Committee, with the help of the H.O.D of the respective department continuously counseled to the victim and theaccused students separately for stopping this type of incident in future. After continuous counselling to the students no such type of incidents was happened till now. He is secured & safe now.





The complaint was addressed to the Deputy Registrar, Aliah University. The same was marked to the Chairperson, ICC on 13.01.2023 received on 18.01.2023 at Newtown Campus.

The Acting Chairperson, ICC immediately contacted to the HoD, Education Dept. for collecting the phone number of the complainant it was not mentioned in the application.

The ICC was intimated at earliest to attend the meeting on 27.01.2023 at 3.30 p.m.

The complainant was also intimated to be present on 27.01.2023 before the Committee.

Minutes:

- The Committee discussed the nature of the complaint and analyzed if it was within the scope of the ICC. The accused mentioned in the application by the complainant is a 1st year student of M. A. in Education, Park Circus Campus of Aliah University.
- Hard copies of the complaint were made available among members present and the following
 - \circ The 1st year M.A (Education) student threatening her and her family
 - The complainant family was very scared and did not attend the classes
- Both the complainant and accused are current students of the university and the offence was nature of threatening. The Committee accepted to consider the same vides UGC regulations 2015 of Prevention, prohibition and redressal of sexual harassment of women employees and students in higher educational institutions.
- The members having decided upon the validity of the case, the complainant was called in for presenting her statements. Some important facts noted from her statements were:
 - The complainant stays at Park Circus campus's ladies hostel. She is from
 - The accused's name is (Education). He is from
 - Both the complainant and the accused were in relationship almost about 4 years and the relationship ended in 2021 end.
 - The complainant's parents were aware about the relationship and disapproved.
 - The accused threatened the complainant's father about one year ago (15.12.2021) over phone. And is not threatening or disturbed or threaten up the Complainant or her family members at all.

- The complainant recently married with who is a student of Civil Engineering of the university on 2nd October 2022. Stays at New Town Campus's boys' hostel and he is from Malda.
- was also called in and the committee members also listened his statements. He confirmed about their marriage.

- It also be mentioned that the Committee found some sort of inconsistency or mismatch in the statements of the complainant.
- The complainant wants the security from the physical damage (acid attack or any kind of physical damage as mentioned in the application) in the campus or outside of the campus.

Resolution:

- 1. After understanding the facts, the Committee has advised them (complainant and her husband) to make a general diary to local police station of Park Circus Campus immediately (within 24 hrs) and intimated the same to the local police stations of (Murshidabad), (Mednipur), and New Town Campus (Aliah University). They were also asked to submit the same copy to the Hon'ble VC, Aliah University and Chairperson ICC.
- 2. The Committee also decided to sit with the accused, to the next meeting after finishing the 1st Yr's Examination to listen his version and response.
