Aliah University Annual Anti-Ragging Report

Academic Year: 2022-2023

Aliah University is committed to fostering a safe, inclusive environment for all students, strictly enforcing a zero-tolerance policy on ragging in accordance with UGC guidelines and legal requirements. The Anti-Ragging Committee recently held an orientation for new students, emphasizing the university's anti-ragging policies and the importance of maintaining a respectful campus culture.

To strengthen this commitment, the university conducted an Anti-Ragging Day awareness program from 2022 to 2023. This included displaying posters and banners across campus to highlight the serious consequences of ragging. Furthermore, all students and their guardians signed affidavits pledging compliance with anti-ragging regulations. Surveillance measures, such as CCTV in critical campus areas, were also implemented to enhance security, while each department appointed a faculty mentor to support and guide new students. A dedicated email has been established to ensure that incidents can be reported promptly and effectively.

These initiatives have played a crucial role in promoting a ragging-free campus, and the Anti-Ragging Committee remains dedicated to enhancing its efforts and introducing additional resources to uphold this standard of safety and inclusivity.

Total Incidents Reported in Academic Year 2022-2023 isthree and summary of incidents are

- A complaint was received from the UGC Anti-Ragging Cell to the University on 14thNovember 2022 (Complaint No. WB_0083 dated 14th November 2022). The Anti-Ragging Committee processed the complaint and sent the report to the UGC Anti-Ragging Cell on 16.12.2022 and the complaint (WB_0083) was closed by the UGC Anti-Ragging Cell.
- 2. A complaint has been received from the UGC Anti-Ragging Cell to the University (Complaint No. WB_0087 dated 22nd November 2022) on 22nd November 2022. Student of M.Tech. Mechanical Engineering has complained against MSc Physics 1st year student and B.Tech. 3rd year, Civil Engineering of Aliah University. On

- 13.03.2023 the Anti-Ragging Committee submitted a report to the UGC Anti-Ragging Cell. They approved the report.
- 3. A complaint has been lodged with the University from the UGC Anti-Ragging Cell (Complaint No. WB_0088 dated 23 November 2022). One student from geography department and two students from education department of Aliah University have complained about the incident which was occurred in University Park Circus campus on 14th November 2022. The accused students are MA 1st year students of Islamic Theology and 2nd year of M.A. Islamic Studies. The Disciplinary Committee has started an inquiry into the matter and is preparing a report which will forward to the UGC Anti-Ragging Cell through the Anti-Ragging Committee of Aliah University. On 27.12.2022 the Anti-Ragging Committee submitted a report to the UGC Anti-Ragging Cell. They approved the report.
