Prices can be quoted in Indian Currency only (₹).No extra payment will be made for carrying of materials involving head load/ trolley etc.
- 4. The vendor should bear all the transportation & insurance **risk** till the delivery point. Selected bidder shall take all possible care for Govt. Property & of any damages due to negligence of his workers.
- 5. On the door delivery will be necessary.
- 6. Experience of supplying similar materials any Central or State Government Organization (At least one)
- 7. The bid should be **complete** in all respects and **duly signed** wherever required. Incomplete and unsigned offer will not be accepted.

No advance payment or payment against Performa invoice will be made. Payment will be made after receipt, inspection, and installation/testing.
