Procedure to take admission:

1. Obtain Financial Clearance by paying requisite fees in the Finance Section. The existing boarders must obtain financial clearance for their tenure with Aliah University's rented hostels at Chingrighata & Mahishbathan. The existing boarders must tender the proof (money receipt) of submission of Caution Deposit.
2. The allocation of Room shall take place in the lobby (Ground Floor) of Boys' hostel building of New Town Campus or in the CVS section of University building (whichever is convenient) after verification of Financial Clearance/ Fees payment and original mark-sheet/ distance certificate/ financial-condition certificate verification against which the online application has been made. **As the list of boarders uploaded was provisional, it is liable to rejection if there is a mismatch between required document (as per notification), submitted document and original document even after payment of requisite fees/ obtaining financial clearance.** The boarders are required to submit two sets of undertakings:
 - (a) Self
 - (b) Parent's/ Legal guardian's (to be submitted within 15 days from admission to the hostel)
3. The Room Keys may be obtained from the Caretakers deputed on adhoc basis.
4. The Mess charges shall be directly collected by the Adhoc Mess Committee and later on by the elected/ selected Mess Committee. **The tenure of the Adhoc Mess Committee shall end on 31/03/2018.** From 1/04/2018 new Mess Committee may be formed by applying appropriate method and in consultation with the Wardens and Caretakers (adhoc). The Adhoc Mess Committee (**valid till 31/03/2018**) has been comprised of the following members:
 - a. Raju Mondal – B.Ed-1st year
 - b. Mirza sabir Ahmed – B.Ed-1st year

- c. Md. Sanaul Islam - B.Ed-1st year
- d. Mir Tasin Hossain - J&MC-1st year

HOSTEL FEE STRUCTURE

Fees Structure for Accommodation in the Boys' Hostel, New Town Campus, Aliah University:

Head	Amount (Rs.)	Remarks
Hostel Caution Deposit	1,500/-	Payable at the time of admission (Refundable)
Hostel Maintenance Charge	500/-	Payable in the month of July every year with seat rent or entering in the hostel whichever is earlier
Hostel Seat Rent	300/-	Payable every month by 5 th day of the month

Notes:

1. The Existing boarders who have already paid the Hostel Caution Deposit need not pay again, but they have to show the money receipt of Hostel Caution Deposit at the time of taking possession of the room in the Boys' Hostel, New Town Campus, Aliah University. Any payment on account of "Accommodation Charges" made for the session of January-June, 2018 may be adjusted upon producing valid proof of such payment.
2. The Mess shall be run by the Mess Committee duly formed by the boarders of the Boys' Hostel of New Town Campus, in consultation with the Wardens and Caretakers of the hostel. The Mess Committee shall function for a month or as decided by the Hostel Administration comprising of the Wardens and Caretakers. The food-menu shall be decided by the Mess Committee in consultation with the Wardens, Caretakers and the boarders and accordingly the food-charges shall be retrieved from the boarders by the Mess Committee on a monthly basis. The Mess Committee shall maintain a proper account of the same which must go through a periodical audit process.
3. The Hostel Seat Rent may be paid at a time for the entire semester also.
