2. Rates quoted should be on F.O.R., Various Location of Aliah University, on Door Delivery basis inclusive of all Taxes/GST, packing freight to destination, Insurances and levies for the items

supplied. Prices must be quoted in Indian Currency only (₹). No extra payment will be made for carrying of materials.

3. Items should be delivered on the door at the O/o Deputy Registrar, Aliah University, Park Circus Campus, 17, Gorachand Road, Beniapukur, Kolkata, West Bengal 700014 at free of cost by the bidders.
4. Warranty/Guarantee: The material must be quoted with a minimum comprehensive Warranty / Guarantee period of One (01) year after the date of delivery and acceptance at final destination.
5. All disputes are subject to exclusive jurisdiction of competent Court and Forum in Kolkata, India only.
