## OFFICE ORDER

The repeated expression of repentance and plea for forgiveness submitted by the 9 (nine) suspended students have been discussed in the 7<sup>th</sup> (Emergency) meeting of the Executive Council held on 18/04/2019.

In line with the resolutions taken in the said meeting the following be noted –

1. Sk Asadat Hossain, Sk Shakil Hossain, Dipu Sk and Abdul Aziz Mallick will be allowed to enter the New Town Campus only for (i) submission of fees, (ii) filling up forms for examinations, (iii) collection of Admit card and (iv) appearing for examinations on scheduled dates and (v) collection of marks-sheets and certificates.
2. Isfakul Alam, Samiran Das, Wasim Akram, Md Abdulla Al Mamun and Sk Didar will be allowed to appear in supplementary examinations, attend classes regularly from July 2019 and complete their academic programmes.
3. None of the above mentioned students will be allowed to enter into the University hostel under any circumstances.
4. These students should not get themselves involved in any act of indiscipline during the rest of their studentship in this University.
5. Each of these students and his guardian must submit an Affidavit from Hon'ble Court accepting these conditions and undertaking to abide by the rules and regulations of the University failing which permanent expulsion will be imposed on them.
6. These students are debarred from taking admission into any other academic programme(s) of this University.
7. These students will remain under strict and constant vigilance till the time they stay in this University as students.
