OFFICE ORDER

The repeated expression of repentance and plea for forgiveness submitted by the 5 (five) expelled students namely – Giasuddin Mondal, Khelafat Hossain, Sk. Tajuddin, Rakesh Sarkar and Akram Raja have been discussed in the 7th (Emergency) meeting of the Executive Council held on 18/04/2019.

In line with the resolutions taken in the said meeting the following be noted –

1. These expelled students shall remain under expulsion for one year w.e.f. 28/09/2018 as per order no. AU/REG/0010/19, dated 03-01-2019. They will be allowed to complete their academic programmes after completion of one year of their expulsion without the hostel accommodation facility.
2. The expelled students who are in their final year of academic programme will not be allowed to enter into the University campus except for (i) submission of fees, (ii) filling up of forms for examinations, (iii) collection of Admit Card, (iv) appearing for examinations on scheduled dates and (v) collection of marks-sheets and certificate.
3. These students have to give an undertaking in a prescribed format provided by the University Authority, in the form of an affidavit from Hon'ble Court countersigned by their guardians failing which the order no. AU/REG/0010/19, dated 03-01-2019 will remain in force.
4. After the completion of one year of expulsion these students will have to complete their current academic programme within the period of valid studentship.
5. If any of these students violate his submitted undertaking in any manner, the University will re-impose expulsion on them.
6. These students are debarred from taking admission into any other academic programme(s) of this University.
