Prices must be quoted in Indian Currency only (₹).No extra payment will be made for carrying of materials.
- Items should be delivered on the door at the Aliah University Boys Hostel, New Town Campus (600+ Boarding Capacity Hostel for Boys) at free of cost by the bidders.
- 4. Warranty/Guarantee: The material must be quoted with a minimum comprehensive Warranty / Guarantee period of One (01) year after the date of delivery and acceptance at final destination.
