### **CALL FOR PAPERS**

"Women Rights in Islam" is a most burning issue which deserves to draw attention of all the responsible citizens of the world in the present perspective. Most of the people are coming up with different ambiguous thoughts towards the ideas and ideals of other religions, cultures and beliefs. Since inception of human society, the essence of the debated discussions based on the status, position, and the role of women has been immensely talked about and reflected by cultures, traditions, and religions down the ages. However, there is a controversy of great dimension when the discussion comes upon the issue of women in Islam, which is basically caused from many misrepresentations and misinterpretations due to lack of knowledge of the teachings of Islam. Very recently, the Government of India has taken up the issues regarding the rights of Muslim women, which is in true sense affecting common Muslim women in India. Triple *Talaq*, *Sharia* Law, divorce, right of inheritance, liberalization of Muslim women, increasing sense of feminism and rising acceptance of LGBT among Muslim women, are the burning topics in our country which have put many Muslims in confusion.

This two-day International Conference will discuss the above -mentioned issues of Muslim women and will focus on Rights and Dignity of Women in Islam in the light of the Holy Quran, the Hadith and the modern sciences. The scholarly discussions will resolve these important issues and will address the common questions – whether the women in Muslim societies are really subjugated or these are misconceptions, falsely fabricated from biased sources? Whether Islamic law has deprived Muslim women of their inheritance? Whether women should be oppressed in the name of religion? Whether Islam permits LGBT? Whether divorce in Islam is oppression and it is against women society? How far Triple *Takaq* is acceptable for all Muslims? How far Shariya Law is necessary for Muslim women? and many such questions.

- 3. Final paper should be submitted (in soft copy) by 31<sup>st</sup> December 2018. (In maximum 15 pages and minimum 7 pages). No paper will be accepted after the above mentioned stipulated date.
- 4. The paper must be prepared **according to the common rules of research**.
- 5. The language of the paper will be **Bengali** or **English only**.
